**Intending to be legally bound, Vendor agrees as follows:**

1. The Site fee must be paid in full no later than **Nov. 15, 2016**. We are limited to 8 vendor spaces. First come, first serve. Your site will be assigned only after payment is received, so prompt payment will aid in placement.
2. Set up is from **11am to 12pm (noon)** and must be complete by **12pm on Dec.17**; removal complete no later 11pm the same day. If Vendor fails to leave site in the same condition as it was at the commencement of the event or to tear down in a timely manner, Vendor shall be liable for all clean up and other costs incurred.
3. The Site is subject to final determination by Da African Village and nontransferable.
4. Vendor shall accept full responsibility for the assigned site and further indemnify, defend, and hold harmless Da African Village, its owners, representatives, and agents from and against any and all damages, claims, or losses, including reasonable attorney's fees, which arise out of or relate to Vendor's use of the site and attendance at the event.
5. Vendor shall obtain commercial general liability insurance, naming Da African Village, as an additional insured, with a reputable company. Vendor is responsible to insure its personal property brought to the event and shall provide worker's compensation insurance for its employees. A certificate of insurance must be provided to Da African Village prior to the event.
6. A CA sales tax identification number (or acceptable equivalent) is required.
7. Any disputes arising pursuant to this agreement shall be subject to the laws of the Commonwealth of California and heard by the state or federal court having jurisdiction over California.
8. Vendor shall follow all rules and regulations of the event and The 418 Project, as may be effect from time to time.
9. Da African Village does not permit gifts, cash, goods or services to be given to anyone involved with the event in exchange for special treatment, favors, or conditions.
10. No tent camping shall be permitted during the event.
11. No generators are permitted.
12. All applications are subject to verification of the provided information. Vendor space is limited.
